I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Abbeycwmhir Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

Fidelity Guarantee Insurance

The Council appears not to have fidelity insurance with its insurance provider. We recommend that the level of cover is at least the balance carried forward plus one precept instalment.

Council did not record the total precept amount within the minutes

The Council did not include the total precept amount within the minutes, only the Band D equivalent. We recommend that the Council include the total precept amount within their minutes

VAT reclaims

The Council has not reclaimed VAT expenditure from HMRC. The Council should ensure it is filing a VAT 126 return to ensure it is recovering its VAT expenditure.
